Auditing available for WNYDA & CDCT members at \$50/day, or \$80 for both days. Lunch included.

Auditing available for non-WNYDA & CDCT members at \$70/day or \$100 for both days. Lunch included.

Auditing available for Pony Club members at \$20/day or \$30 both days. Lunch **NOT** included.

Demo rider lesson cost for WNYDA & CDCT members at \$250*/weekend (must ride both days). Lunch included.

Demo rider lesson cost for non WNYDA & CDCT members at \$350*/weekend (must ride both days). Lunch included.

****Demo rider lesson cost includes: One approximately 45-minute Lesson plus Stall and Facility Fee for each day. Riders may arrive between 4:30 -8:30 pm on***

Friday. Horses may be ridden in the large indoor arena Friday 4:30-8pm. The large indoor arena may also be used Saturday and Sunday between 6-8am, during breaks, or after the last ride of the day until 7 pm on Saturday.

Application Criteria:

-Auditor applications will be accepted with payment to hold spot until spots are filled per facility and COVID-19 requirements. No exceptions. Once full, a waitlist will be started. Refunds will be issued prior to 10/1/25.

-Demo rider applications will be accepted from **July 15-August 31, 2025**, with payment to hold spot. If not selected, the check will be destroyed, or payment will be returned to applicant within two weeks after event completion.

-A total of 7 lessons will be held per day. Lisa Schmidt will be choosing demo riders based on the suitability of the demo rider/horse pair for the symposium.

-Demo riders and reserves will be notified by September 25, 2025. Reserve riders will be given a free audit for the weekend if the riding slot does not open as compensation for keeping their weekend open.

-Photographs of auditors and demo riders may be used for WNYDA newsletters and/or social media.

-Unfortunately, due to space limitations we will be unable to offer free audits for grooms.
